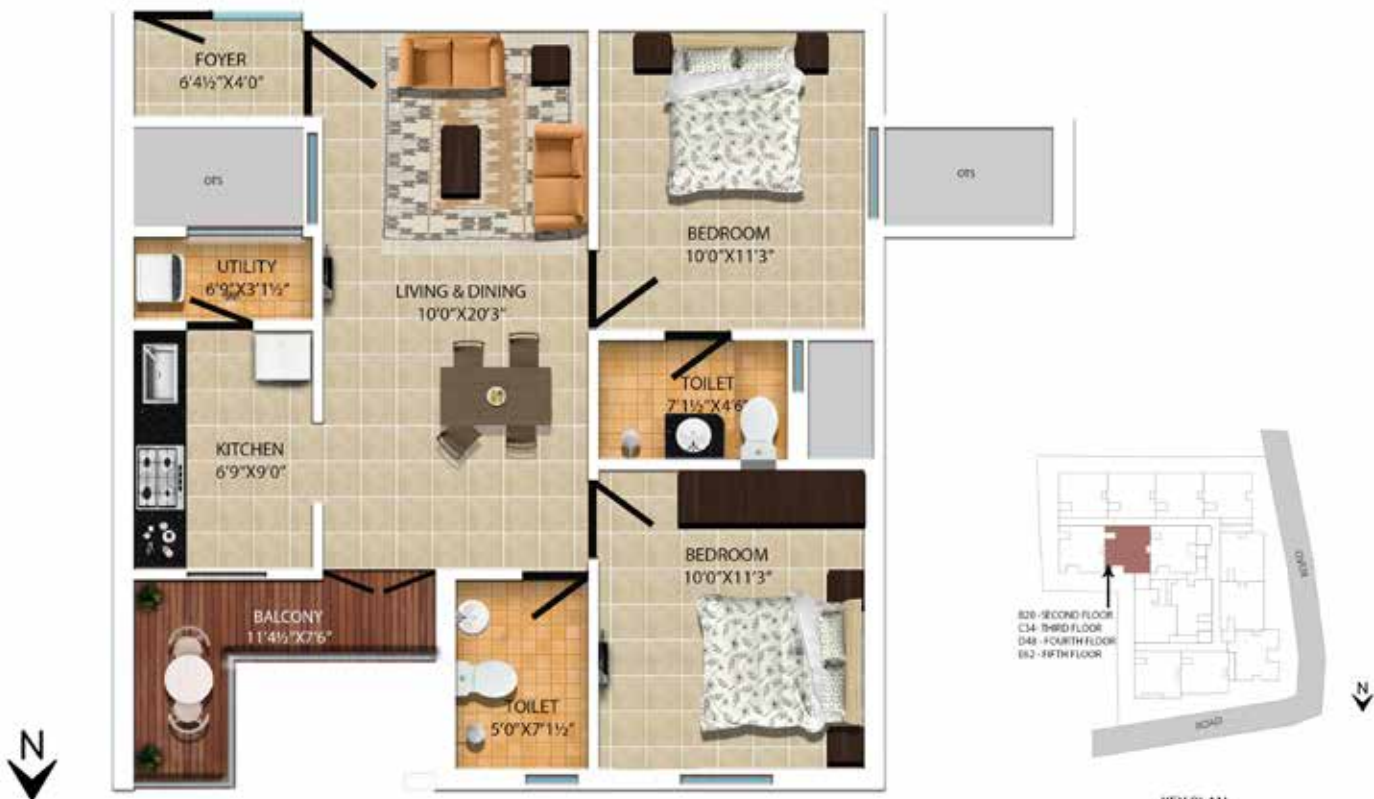

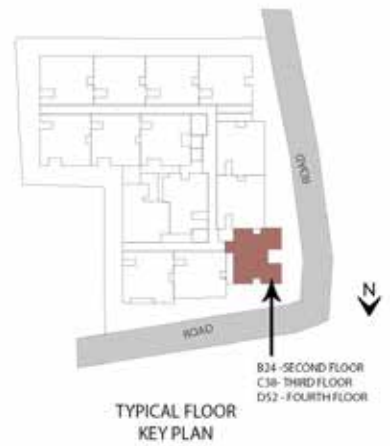
SECOND,THIRD,FOURTH - TYPICAL FLOOR PLANS

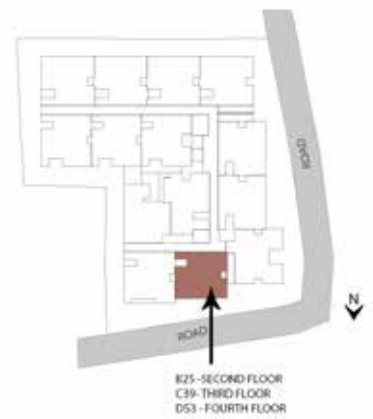
SECOND,THIRD,FOURTH FLOORS -TYPICAL FLOOR PLAN

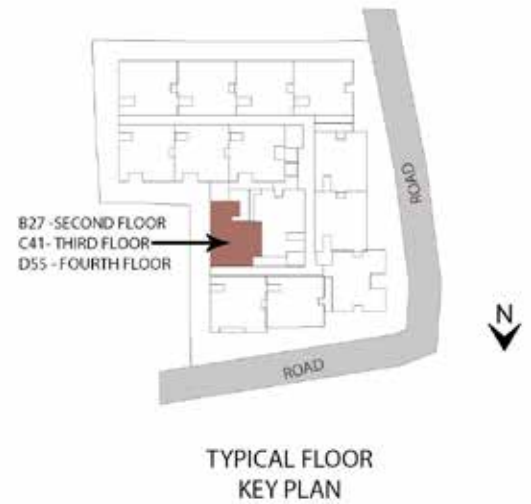

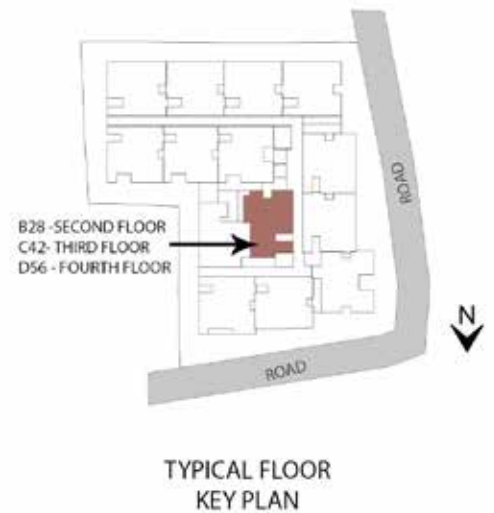
SECOND,THIRD,FOURTH FLOOR PLAN -TYPICAL FLOOR PLAN
